Dear Shareholders,

Due to inefficiencies with past Livestock Water Runs and questions regarding eligibility for shareholders to receive water during these runs, we are asking you to download, complete all requested information and return this Livestock Water Run Eligibility Form to our office by the end of September. This form can be found on our website [www.floridaditch.com](http://www.floridaditch.com) under the forms section. This form will allow us to determine, in advance, if you are eligible to receive Stock Water for the upcoming year.

If it is determined you are eligible, you will be placed on a Stock Water Run Pre-Qualification List. During times of Stock Water Runs, you will still have to place a call to the Ditch Manager in order to receive water. We are hoping by using this form, it will help ensure that when you call for your stock water there will be no questions as to your eligibility for water delivery.

The Qualifications to receive Livestock Water are found in the Rules and Regulations Section 9.3 and are as follows:

## 9.3 Livestock Water

To be eligible for livestock water, (1) applicant for livestock water must either own livestock or lease to someone who owns livestock; (2) The property must have a storage facility to hold the stock water, (3) the livestock must have access to the storage facility, and (4) the applicant for livestock water must sign an Affidavit verifying that he files a Schedule F or other tax return form showing income from Livestock or leases to someone who files said forms. Upon request, the applicant for livestock water must provide the Ditch Company with a copy of the schedule F or other tax return form from his past year's tax return which shows income from Livestock. Livestock water runs, if any, will be advertised annually in the fall in the Durango Herald Newspaper, or another newspaper of general circulation in La Plata County. **During times of Stock Water Runs, you will still have to place a call to the Ditch Manager in order to receive water.**

\*\*Form MUST be completed by the shareholder or lessee to be considered for the stock run. Lessee must provide copy of Lease with this form.

## Livestock water eligibility form "Stock Water Run"

I \_\_\_\_\_, hereby submit my request to be considered eligible for the livestock water runs during the year. Per the Company Rules and Regulations Section 9.3 Livestock Water Section, if it is determined I am eligible to receive Livestock Water, I understand my name will be placed on the Livestock Water Run eligibility list. The Stock Water I use is for my livestock or for the person I rent/lease my property to and they are someone who uses it for livestock. If I rent/lease my property to someone with livestock, I agree to provide a copy of the rental/lease agreement. If requested I agree to provide a list of all livestock on the property the water is intended for and I have a pond to store this water on my property. I understand that upon request, I must provide the Ditch Company with a copy of the schedule F or other tax return form from his past year's tax return which shows income from Livestock.
